| Why? | Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do. |
| What? | The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security number and Date of Birth • Name and Address |
| How? | All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reason financial companies can share their customers' personal information; the reasons Harley-Davidson Insurance Services, Inc. ("HDIS") chooses to share; and whether you can limit this sharing. |

| How does Harley-Davidson Insurance Services, Inc. protect my personal information? | To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. |
| How does Harley-Davidson Insurance Services, Inc. collect my personal information? | We collect your personal information, for example, when you <ul style="list-style-type: none"> • Request a quote or Apply for insurance <p>We may also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p> |
| Why can't I limit all sharing? | Federal law gives you the right to limit only <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes – information about your creditworthiness • affiliates from using your information to market to you • sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state laws</p> |
| What happens when I limit sharing for a policy I hold jointly with someone else? | Your choices will apply to everyone on your policy. |

| Definitions | |
| Affiliates | Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include companies such as: <ul style="list-style-type: none"> • Harley-Davidson Financial Services, Inc. • Harley-Davidson Credit Corp. • Eaglemark Savings Bank • Harley-Davidson Motor Company • Harley-Davidson, Inc. |
| Nonaffiliates | Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> • Harley-Davidson Insurance Services, Inc. does not share with nonaffiliates so they can market to you, except as permitted by law. |
| Joint marketing | A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners include, but are not limited to: <ul style="list-style-type: none"> • Credit card companies • Insurance companies |

If you want to opt in, please send a written request to the HDFFS Privacy Officer at the address noted on the Mail-In Opt-Out Form.</i></p> <p>For California residents: <i>In accordance with California law, we will not share information we collect about you with companies outside of our corporate family, except as permitted by law, including, for example, with your consent or to service your account. We will limit sharing among our companies to the extent required by California law.</i></p> | |
