This warranty is in lieu of any and all other warranties, expressed or implied, including those of fitness for a particular purpose and merchantability, in no event shall Harley-Davidson® be liable for costs or expenses directly or indirectly arising from the use of Harley-Davidson Motorclothes® product, or for special, indirect, incidental or consequential damages of any nature whatsoever, except for the obligation to repair, replace, or issue credit for goods covered by this warranty.
